Additional Services

Before Care (If needed)	\$5 per day (per child)	Before Care is available from 7:00am-8:00am.

Refund Policy for Early Withdrawal

*Private Pay Families

Withdrawn within 1 week of School beginning	95% Refund	Withdrawal notice must be given prior to withdrawal. Refunds may take up to two weeks to process.
Withdrawn prior to end of 1 st quarter	75% Refund	Withdrawal notice must be given two weeks in advance to receive refund. Refunds may be given at time of withdrawal.
Withdrawn prior to end of 2 nd quarter	50% Refund	Withdrawal notice must be given two weeks in advance to receive refund. Refunds may be given at time of withdrawal.
Withdrawn prior to end of 3 rd quarter	25% Refund	Withdrawal notice must be given two weeks in advance to receive refund. Refunds may be given at time of withdrawal.
Withdrawn prior to end of 4 th quarter	No Refund	No Refund given.
